5th National Symposium of Acupuncture Association of India (NASAAI):

The 5th National Symposium of Acupuncture Association of India (NASAAI) 2015 was inaugurated on **5th December**

2015 by **Sri Ram Naik, Hon'ble Governor of U.P.** in the presence of **Prof. Yongjin Chen, Deputy Chairman, South China Research Centre for Acupuncture & Moxibustion, Guangzhou, China**, Swami Muktinathananda, Secretary, Dr. B.J. Bhattacharya, Dr. M. Gantait, General Secretary & President of Acupuncture Association of India (AAI), Kolkata, and nearly **50** professional acupuncturists from all over the country besides a large number of distinguished citizens of Lucknow.



The programme started with National Anthem followed by lighting of lamp amidst Vedic chanting by the monastic brothers of the Ramakrishna Order. Swami Muktinathananda said in his welcome address that this symposium on Acupuncture, which is being organized in this part of the country for the first time, will definitely enhance the propagation of this particular alternative therapy as an important tool for providing improved care for patients from

far and near. He said that Alternative Therapy is being increasingly accepted as a supplementary treatment procedure which may be applied hand in hand with other ongoing methods. He further added that this therapy which was started periodically in Vivekananda Polyclinic & Institute of Medical Sciences, Lucknow with auricular Acupuncture several years ago, took a regular shape since 20th December, 2014 in collaboration with AAI, Kolkata, by way of introducing regular acupuncture clinic at the Institute as well as its rural outreach centers; besides imparting training courses recognized by W.H.O.

Dr. B.J. Bhattacharya, General Secretary, AAI, introduced the topic saying, “World Health Organization promotes spread and development of acupuncture throughout the world. In developed countries like USA and Europe, millions of people are undergoing acupuncture therapy and such other traditional therapies. Their Governments endorse acupuncture treatment and training schemes. In India acupuncture therapy was introduced in 1959 at Kolkata by Dr. B.K. Basu. West Bengal Government has given legal recognition to acupuncture in 1996.

Dr. M. Gantait, President of AAI, Kolkata, said in his Key-note Address that the doctors of modern medicine should integrate and assimilate the tested merits of different systems for better patient care. World Health Organization has recommended application of Acupuncture Therapy in 43 specific ailments including Osteoarthritis, rheumatoid arthritis, frozen shoulder, tennis elbow, bronchial asthma, facial paralysis etc. Acupuncture is practiced in more than 150 countries around the world including USA, Canada, UK, France, Germany, Italy, Russia, China, Japan etc.

Prof. Yongjin Chen, the Guest of Honour, who represented World Federation of Acupuncture Moxibustion Society, Beijing, revealed the positive results obtained through the recent scientific research in China and stressed on the need of propagation of Acupuncture throughout the world.

Sri Ram Naik, Hon'ble Governor of U.P. extolled this therapy and congratulated the Institute for its endeavours in promoting this technique in U.P. and adjoining areas. A Souvenir containing general information on acupuncture and abstracts of several scientific papers was released by the Governor to mark the event. He also stated that in view of its increasing success, this therapy should be recognized by the State Govt. & be included in the State Health Scheme, as has been done in West Bengal.

In this symposium nearly 30 scientific papers were presented by speakers from Kolkata, Delhi, Mumbai, Hubli, Rourkela, Indore, Maharashtra, Chennai, Ludhiana, & Lucknow. Topics of discussion were on pain management, arthritis, newer techniques, clinical researches, comparison of Acupuncture and Yoga etc. Approximately 100 participants attended the symposium. Hopefully, the symposium would have enabled the attending acupuncturists to update their knowledge towards improved patient care.

3rd Annual Conference of UP & Uttarakhand:

3rd Annual Conference of UP & Uttarakhand Chapter of Indian Association of Paediatric Surgery (IAPS) was



inaugurated on 23rd January, 2016 by the Chief Guest, Prof. Ravi Kant, Vice Chancellor, KGMU, Lucknow. He emphasized the need of close co-operation amongst different specialties for optimum utilization of limited resources in this region. Further, he stressed upon the importance of research in super speciality areas like Paediatric Surgery in order to focus on preventive measures for different conditions.

Swami Muktinathananda, The Secretary of the Institute welcomed the Paediatric Surgeons attending the conference and complimented the UP & Uttarakhand Chapter of IAPS for having chosen the hospital as the venue for this august assembly. He also said that it is indeed a rare privilege to have so many eminent Paediatric Surgical Faculty of National Repute and also Senior Paediatric Surgeons from the UP & Uttarakhand States participating in

the conference and sharing their vast knowledge and experience. He added that this event is as holy as performing a Jnana-Jajna Yajna-a ceremonial sacrifice of yore for acquisition of knowledge.

Prof. A.K. Wakhlu the Guest of Honour spoke about the need of training more Paediatric Surgeons in UP and Uttarakhand. The population of these states requires at least 400 Paediatric Surgeons to cater to the needs of children, as opposed to the present strength of some 75 such surgeons.

Dr. S.N. Kureel, Professor & Head, Department of Paediatric Surgery, KGMU, Lucknow & Chairperson UPIAPS & President Elect, IAPS informed that a new 1000 bedded hospital for the children of the state is under active consideration of the Govt. and is likely to be approved very soon.

Dr. Kishore Panjwani Sr. Consultant Paediatric Surgery, Pushpanjali Hospital, Agra & President IAPS emphasized about the need of developing Paediatric Surgery Centres in other part of the country.

Dr. Ashutosh Pandey, Visiting Consultant, Paediatric Surgeon & Organizing Secretary UPIAPS informed that Paediatric Surgery has grown by leaps and bounds in the past couple of decades due to rapid advancements in the surgical techniques, safer anaesthesia, better postoperative care including intensive care.

Prof. Mohan K Abraham, Prof. & HOD, Paediatric Surgery, Amrita Institute of Medical Sciences, Kochi delivered Asopa-Wakhlu Oration in which he discussed about Urinary problems in children and their surgical management.

Eminent National Faculty of Paediatric Surgeons viz. Prof. Veereshwar Bhatnagar and Prof. Minu Bajpai from AIIMS, New Delhi, Dr. Ravindra Ramadwar from Hinduja Hospital, Mumbai, Dr. K Ramesh Reddy from Niloufer Hospital, Hyderabad and Prof. S. Ramesh from IGICH, Bengaluru participated in the conference, besides demonstrating surgeries on 4 cases of Ano-rectal malformations by conducting Live Operative Workshop. CME lectures on some interesting aspects of Paediatric Surgery as well as Joint Symposium on topics of common interest regarding comprehensive management of children with surgical problems were also organized.

It is hoped that the Conference will enable the participating Paediatric surgeons of UP and Uttarakhand to enrich their knowledge so as to provide better care for their patients.



Medical Camps:

- **Diabetes Acupuncture Camps:** A monthly Diabetes Acupuncture clinic under the guidance of Dr. Jay Kumar Dixit, President, National Acupuncture Organization of India was arranged on 5th December 2015 & 4th January, 2016. A total of 43 diabetic patients were seen during the camp.
- **Free Cardiology Camps:** Three cardiology camps were organized in the months of December 2015 & January, 2016 at Paraspur (Gonda), Kushinagar & Dudhi (Sonbhadra) where a total of 259 patients were provided free consultation as well as free investigation including ECG, Blood Sugar, as well as Echo cardiogram, as per requirements. Of these, 04 patients suffering from ASD and Mitral Valve Disease were shortlisted for surgical intervention, which were to be performed in VPIMS either free or at highly subsidized rate by a team of competent surgeons.

Improvement in the Hospital Infrastructure:

In the past two months, a large number of renovation of various wards/departments have been under taken in the hospital to improve the overall patient care services. The wards/departments viz. Intensive Care Unit (ICU), Private Rooms in the Obs & Gynae Ward, and Dietitian Consultation Room were inaugurated and declared open by Swami Muktinathananda, Secretary of the Institute in the presence of Consultants and hospital Staff.



The Endoscopy Room of the Gastroenterology Department has been shifted to the lower ground floor of the Institute. The newly constructed air conditioned Endoscopy Centre with spacious Endoscopy Room, Recovery Room, Registration Counter, Waiting Area were inaugurated by Swami Muktinathananda, Secretary of the Institute on **24th December 2015**, in the presence of Dr. Gourdas Choudhuri from Fortis Research Medical Institute, Gurgaon, Gastroenterologist of VPIMS, and other hospital staff. The Endoscopy Centre is equipped with the State of the Art Upper/Lower GI scope, Colonoscope, ERCP scope and

C-Arm carrying out procedures like Endoscopy, ERCP, Colonoscopy and Sigmoidoscopy in a totally aseptic conditions.

Village Health Programme:

The Village Health Programme team of VPIMS comprising General Physician, Ophthalmologist, Gynaecologist, Paediatrician, Dental Surgeon, Ayurvedacharya, DNB trainees and paramedical staff with equipment and medicines continued their programmed visits to **KATRA BAKKAS** in **Lucknow District on Mondays**, **HEERPUR ATARIA** in **Sitapur District on Wednesdays** and **Saturdays**, **RAMVANKUTIR** in **Barabanki District on Thursdays** and **MAHMOODABAD** in **Sitapur District on Fridays**. Charity Activities:

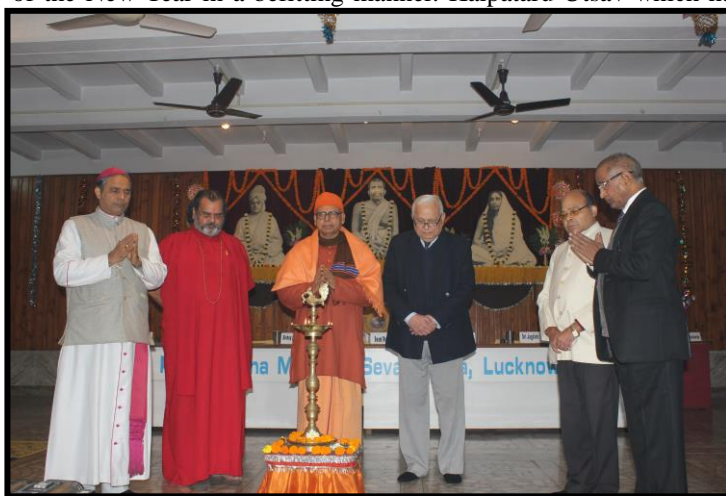
- 987 In-patients were treated totally free of charge.
